Conditions to benefit from the tax refund

The tax refund is a reimbursement of the VAT granted to people visiting France for less than 6 months.

Purchased goods must be reserved for personal use, kept available for inspection at the border, unused and transported in the customer's personal luggage.

The tax refund is not intended for residents of the European Union, overseas departments and Monaco.

It does not concern students, trainees and immigrant workers living in France, even if they definitely return to their country of origin.

How to benefit from the tax refund?

In order to speed up the processing of your file, please send us these elements - perfectly legible - as soon as your order is confirmed. Upon receipt of these documents and once your watch is delivered, we will send you the official Tax Free Form completed.

When you leave the European Union, please present to Customs officers for registration the tax free form and the invoice corresponding to your purchases, using the PABLO barcode reader. Your refund will then be made within an average period of 6 weeks by bank transfer or cheque.

To note:

Your passage to customs must take place within 3 months from the end of the month in which the watch was delivered to you in person, through the Trilobe Network (be it at our Pied-à-Terre in Paris, or during one of our handing-over events). We invite you to consult the website of the French government for more information.

The use of tax refund is not mandatory. Trilobe Watches reserves the right to refuse a refund request that does not meet the requirements of the Official Customs. We take every care to update this notice. Trilobe Watches can not however be held responsible for any errors in the content of the information above. In particular, we will not be able to cover any reimbursement in case of non-compliance with administrative procedures or if your order does not meet the necessary criteria to benefit from the tax refund.
